



















#### **Transformation!**

During Fiscal Year 2017, the Maryland Area Health Education Center West (AHEC West) began implementing extensive changes to its continuing education and training programs for health professionals. Mandates from our federal program required that we discontinue providing education and support for individual professional disciplines and completely shift our focus to interprofessional education as defined by the Health Resources and Services Administration. As a result, we worked diligently with our professional Caucuses to serve them well and transition them to new homes. What a shift in identity for AHEC West! For 40 years we proudly supported their quest for up-to-date and evidence-base education to meet licensure requirements and identified interests. Our Caucuses always supported our interprofessional education program offerings and were often the impetus behind the identification and implementation of topics and courses. We are sad to see them go and will always treasure our long history with them as we establish a new identity in the education arena.

Of course, there is always a positive outcome with change, and AHEC West is embracing it thoroughly as we move forward to meet the challenges in health professions education and remain relevant in the current healthcare environment by fully embracing interprofessional education for professionals as well as students and engaging with our University of Maryland Program Office to plan entirely new programs that meet needs.

While some signature and formerly defining programs are no longer with us, our charge to meet our service area's identified needs remains our mission: to improve access to and promote quality healthcare through education and other partnerships. AHEC West continues to focus on health professions education pipeline programs, to provide youth with hands-on activities with healthcare topics and health professionals through training and job shadowing experiences. We are proud to provide programming that enrolls residents of Washington, Allegany, and Garrett counties in much-needed health insurance plans. Our interprofessional geriatrics education and training programs continued to thrive. Clinical education of students began a shift to an interprofessional training, and remained a key programmatic area of our mission, as did our networks that target the unmet healthcare needs of the region, such as unique programs to increase access to oral and behavioral health. Fiscal year 2017 also saw a dramatic increase in the training and employment of Community Health Workers, and initiative of AHECs nationwide, and AHEC West, kept busy training and hiring CHWs to continue the efforts to reduce suffering, improve population health, and increase access to positive life altering services.

We commend the Board of Directors and the dedicated staff for a productive and successful year. And in closing, we take some time to reflect on how an AHEC West effectively serves the community, which is through extensive and meaningful partnerships. So, once again, we thank our health professional Caucuses and our community and academic partners for allowing us the privilege of working with them to address regional needs.

AHEC West's signature health careers pipeline program this year celebrated 12 years of nurturing students' interest in becoming health professionals.

Students from rural Maryland were exposed to job opportunities in the health field through the ECHO Program throughout the year, including the Summer ECHO Program; students from six counties and three states participated.

The highly interactive, week-long residential summer program provides high school students with a variety of learning opportunities through presentations, tours, job shadowing and hands-on learning. The three week summer program included ECHO 101 and ECHO 201.


ECHO 101 exposes students to nearly 100 careers in health. Partner sites include University of Maryland School of Medicine, Western Maryland Health System, Garrett Regional Medical Center, Garrett College, Allegany College of Maryland and Allegany County Health Department, among many others. Students also learn about college entrance expectations, financial aid opportunities and resume writing skills.

They become CPR/First Aid certified and learn basic health care skills.

ECHO 201 is a second-year program that builds on ECHO 101. Students are immersed in hands-on activities related to chosen career paths. This year's program included exposure to careers in health at West Virginia University, and a visit to National Institute in Health, National Library of Medicine, volunteerism at Goodwill Mennonite Services, and continued reinforcement work on college entrance exams, financial aid and resume writing skills.

ECHO 301 allows students to continue with job shadowing in their area(s) of interest. Several 301 college students come from Potomac State College, Frostburg State University, Allegany College of Maryland, and other universities and colleges. These students perform numerous hours of shadowing in rural Maryland with a variety of preceptors.

Nearly 90 preceptors, providers, and partners make ECHO a successful and truly unique program that continues to grow and evolve each year.



## **Caucuses & Continuing Education**

The dedication and commitment provided to AHEC *West* from the members of the nine health **professional** Caucuses continues to be the core of the continuing education program success.

In fiscal year 2017 the dedication and commitment provided to AHEC West from the members of the seven active health professions Caucuses continued to be the core of the continuing education program success.

The disciplines represented by these caucuses include dentistry, dietetic, nursing, psychology and professional counseling, nurse practitioner and social work. Because of the collaborative relationship established between these caucuses with health care organizations and educational institutions, the continuing education programming continued to serve the needs and interests of our local providers.

During fiscal year 2017, fifty-three continuing education courses were sponsored or co-sponsored for a total of 2,140 health professionals trained, awarding 178 credit hours.

In cooperation with these partners, training needs are assessed and programs are developed and conducted using national, regional, and local experts as lecturers and consultants.

During fiscal year 2017, fifty-three continuing education courses were sponsored or cosponsored for a total of 2,140 health professionals trained, awarding 178 credit hours. Presentation formats included conferences, workshops, lectures and webinars.

By providing quality, diverse and affordable educational opportunities, AHEC West has assisted with the retention of health professionals in the region, as well as assisted them to improve the health care provided to the citizens of Western Maryland.

Unfortunately, funding restrictions imposed for FY18 required that AHEC West discontinue caucus support with end-of-year efforts concentrated on transitioning caucuses to other host agencies and assisting with spend down of any remaining caucus funds. AHEC West has greatly valued the time and the efforts that have been dedicated by caucus members over many, many years. These caucuses have been the leaders within their respective professions and AHEC West staff will be forever proud of working alongside each of them in the pursuit of their many caucus goals and resulting accomplishments.

# AHEC West continues to lead national efforts to raise HPV Immunization rates through Provider Education

The National AHEC Organization (NAO) received funding from the Centers for Disease Control and Prevention for a project to provide education to health professionals regarding the Human Papillomavirus (HPV) vaccine.

Through this cooperative agreement, NAO will strengthen HPV vaccination recommendations and elevate awareness on HPV vaccinations and their role in cancer prevention. For Year 3 (October 1, 2016 – September 30, 2017) of this five-year project, leadership shifted from using 10 Regional Coordinators to using four Project Specialists to focus on these core priority areas: Marketing, Partnership, Continuing Education and Integration. AHEC West Program Coordinator, Joy Taylor, was selected to be one of these four Project Specialists supporting training efforts to the 44 state entities across the country.



National AHEC Organization HPV Immunization Project



#### Program goals include:

- Provide clinician outreach and training
- Disseminate educational materials
- Increase and form strong partnerships
- Push prioritization of HPV vaccination efforts to promote cancer prevention and bolster the number of HPV vaccinations administered in the region.

Outcomes included 321 HPV training events conducted where 14,040 health professionals received training.

The breakdown results are 2,262 physicians and other primary care providers, 4,136 nurses, 242 oral health professionals, 309 pharmacists and 3,758 other health professions. Additionally, 1,838 health professions students also received training, representing a variety of disciplines.

## Western Maryland Health Insurance Connector



Starting on July 5th, 2016 AHEC West partnered with the Maryland Health Benefits Exchange to provide in-person health insurance enrollment assistance to consumers in Washington, Allegany and Garrett counties. This program, named "Western Maryland Health Insurance Connector," is the official Connector Entity for the far western counties in Maryland.

The program employs a staff of eight, with one person located in Garrett County; four in Allegany County and three in Washington County. All staff are certified as Navigators for the Maryland Health Benefits Exchange.

AHEC West has partnered with Mountain Laurel

Medical Center, Tri-State Community Health Center, Family Healthcare of Hagerstown and Washington County Health Department to provide an additional six Navigators to the community. Allegany County Health Department, Garret County Department of Social Services, and Washington County Health Department all host Navigators at their locations. The Connector Program has also partnered with WMHS at their "hot spot" clinics and the Union Rescue Mission.

In its first year we provided in-person assistance to 2,392 people during 1819 appointments. We enrolled 1,540 people in insurance, 715 were enrolled for the very first time. Connector staff logged over 7,000 phone calls as well.
