# From Our Chairpersons

Leading the Western Maryland Area Health Education Center (WMAHEC) has experienced an extraordinary year through major personnel changes while employed in the continuance of programs and community support of rural health education.

Don Spencer, the executive director of this organization for 18 years, announced his December retirement in August of 1997. An able search committee comprised of Dr. John Davis, Tom Jimerfield, and Dr. Gail Mazzocco worked many long hours to recruit, interview, and select an individual who could carry this organization into the next millennium and continue to maintain the integrity and focus that has been so important to our success. WMAHEC's services and programs in information, advocacy, recruitment, and retention have continued unabated through all of this major change. The year ended in a very successful luncheon at Rocky Gap where the people who contributed to these programs were recognized. This next year should be just as exciting as the WMAHEC proactively moves forward to embrace the challenges that the changes in health care delivery initiatives will bring to our mission.



As society moves toward the new millennium, education and health care are two very dynamic environments. The Interdisciplinary Health Education Council (IHEC) has the responsibility of advising Western Maryland AHEC (WMAHEC) on both. Through strategic action planning, attention has been devoted to collaborating with the community in education and health.

Numerous examples of how WMAHEC has enhanced community/campus partnerships can be found in the highlights of this fiscal year. Through the *Interdisciplinary Prevention in Rural Communities* project, students and faculty from four universities partnered with community site representatives from Head Start and senior centers to develop health promotion projects which address the needs of those populations. With funds from the Geriatrics and Gerontology Education and Research (GGEAR) program, mini-grants enabled area agencies to plan geriatric continuing education addressing their unique needs. This annual report gives numerous other examples of WMAHEC's collaborative efforts with various sectors of the regional community. Volunteer hours contributed to WMAHEC programs are valued at \$923,608.

# The Year In Review

#### Information

- Educated 220 individuals about information services and processed 700 information requests.
- Developed and published Web site at www.allconet.org/ahec.
- Published Health Voice, a newsletter identifying resources and health needs in the region.

#### Advocacy

- Began community health needs assessment project with town meetings and survey.
- Networked with 138 community agencies, coalitions, and task forces.

#### Recruitment

- Supported 260 students in education pipeline preparing for 16 different health care disciplines.
- Introduced health careers to middle school students in after-school programs.
- Offered special rotations for first-year medical students from University of Maryland and residents from Union Memorial Hospital.

#### Retention

- Established mini-grants with the Geriatrics and Gerontology Education and Research program.
- Collaborated to offer 250 continuing education hours for 1,200 participants.

# Information Services

While maintaining service contracts and networking relationships with area libraries and health care organizations, WMAHEC focused its information services efforts on introducing health care professionals to the Internet and enhancing the skills of those already surfing the World Wide Web.

WMAHEC's efforts to connect area health care professionals with reliable information and efficient use of information technology included these highlights:

- ◆ Trained Somerset Hospital and Garrett County Memorial Hospital employees on Internet Grateful Med and Loansome Doc.
- Demonstrated Internet search strategies and provided hands-on training for environmental health employees at the Allegany County Health Department and Maryland Department of the Environment.
- Exhibited information and offered training on Internet Grateful Med at the Fourth Annual Rural Health Conference in collaboration with other AHECs.
- ◆ Exhibited resources at continuing education course *Chronic Disease is Preventable:* Help Design a Program to Work.
- Provided Internet training for Psychology, Occupational Therapy, and Nursing Caucuses.
- Trained clinical education and health career recruitment program students on Internet and other health information resources.
- Provided orientation to Eastern Shore AHEC Learning Resource Center staff.

# Health Care Advocacy

WMAHEC collaborated with A STAR! in Western Maryland, an AmeriCorps program, to provide a forum for health care consumers and providers to discuss current resources and perceived health care needs. Results of the project will be presented in an upcoming report to be distributed to policy makers, health care providers, consumers, and other interested

This project helped health care administrators, practitioners, and consumers meet and communicate, with these highlights:

- Developed and disseminated a Community Health Survey completed by 454 individuals.
- Held 9 town meetings with a total of 154 attendees in Garrett, Allegany, and Washington Counties.
- Published 4 issues of Health Voice, a newsletter combining information on health care programs and access issues, reports on survey results and town meetings, and tips for healthy living.



  - Met bimonthly using interactive video classrooms at Garrett Community College, Allegany College of Maryland, Hagerstown Community College, and Frostburg State University.
  - Began holding individual county meetings with health care, government, education, and business sectors for input to regular Coalition meetings.


# Clinical Education

WMAHEC continued to coordinate and facilitate rural rotations in Western Maryland and the surrounding region for health professions students and medical residents. WMAHEC linked students with preceptors, provided or located housing for out-oftown students, offered information resources and training, and facilitated weekly interdisciplinary seminars. The Clinical Education program expanded this year to include residents from Union Memorial Hospital in Baltimore, and a new program for first and second-year medical students from the University of Maryland School of Medicine was initiated.

## IRT

#### Interdisciplinary Rural Training

Interdisciplinary Prevention in Rural Communities forged new collaborative relationships between educational institutions and community programs (Head Start programs and senior centers) serving low-income residents of Western Maryland, with these highlights:

- Supported a continuing education course titled Chronic Disease is Preventable: Help Design a Program to Work.
- ◆ Developed 2 courses for credit in 8 different degree programs at University of Maryland; Towson University; Allegany College of Maryland; and University of Pittsburgh:

# **GAIT**

#### Geriatric Assessment Interdisciplinary Team

The Geriatric Assessment Interdisciplinary Team (GAIT) project continued to provide opportunities for students in a variety of health care disciplines to meet and develop working relationships with each other, health care professionals in geriatric settings, and patients. Each project consisted of teambuilding seminars, interdisciplinary team planning, patient assessment, and developing team treatment plans.

In FY 1998, GAIT brought students, professionals, and patients together with these highlights:

- Coordinated 9 projects in geriatric settings.
- Included students from various disciplines from the University System of Maryland health professions schools.
- ♦ Added 3 new sites (Devlin Manor Nursing Home, Frostburg Village Nursing Care Center, and Homewood of Williamsport).
- Assisted the Eastern Shore AHEC in planning 2 GAIT projects.

#### Student Health Action and Recruitment Education

S.H.A.R.E. introduced middle school students to health careers, with these highlights:

- ◆ 154 middle school students were given health career-related information.
- ◆ 55 middle school students completed family health needs assessments.
- ◆ 11 students participated in the health careers camp held June 15-26 at Frostburg State University, with these highlights:
  - Tour of Ruby Memorial Hospital and West Virginia University Health Sciences Center.
  - ◆ CPR/First Aid training.
  - Water safety demonstration at Riverside YMCA.
  - Teambuilding and rock climbing.
  - Art and music therapy.

Health Careers Opportunity Program

WMAHEC continued its collaboration with West Virginia University (WVU) under the Central Appalachian Health Careers Opportunity Network, with these highlights:

- Visited 16 high schools and 14 colleges and universities in Western Maryland and West Virginia to promote health careers and to advise students about the educational pathway.
- Coordinated a preliminary education program with 13 entering freshmen and a facilitating entry program with 9 students held at Frostburg State University beginning in June.
- Assisted with recruiting 50 students who attended preliminary education, facilitating entry, and retention programs held at WVU in May and June.

## **NEOP**

#### Nursing Education Opportunities Program

NEOP continued to introduce students to the nursing profession. Recruitment efforts focused on the need for bachelor's prepared and advanced practice nurses due to changes in health care delivery.

In fiscal year 1998, NEOP brought students, nurses, and educators together in these ways:

- Completed the first summer recruitment workshop and preliminary education program (June-July 1997) with 14 students.
- Visited 16 high schools, speaking with 430 students about the changing nursing field.
- Held an information session open to the public at Frostburg State University.
- Planned recruitment workshop and preliminary education programs to be held in July 1998 (FY 1999).

# University of Maryland School of Nursing Western Maryland Outreach

WMAHEC continued to support the undergraduate outreach program in Cumberland and Hagerstown. In 1998, 23 students at the 2 sites completed the program and now actively contribute to health care services in the 3 Western Maryland counties and in Frederick County. Graduate-level programs were also supported.

WMAHEC helped promote the University of Maryland Family Nurse Practitioner program in Cumberland, which currently includes 6 students from the WMAHEC service area.

# Towson University Occupational Therapy Department Western Maryland Outreach

Eighteen students continue in the occupational therapy outreach program, with BS-level students beginning advanced clinicals in summer/fall. WMAHEC supported the outreach program in FY 98 by providing space for staff and classes, proctoring exams, housing outreach program resources, and serving in an advisory capacity via the Occupational Therapy Caucus.

## University of Maryland School of Social Work Western Maryland Outreach

WMAHEC's support for the MSW outreach program was limited in 1998 to providing space for the Western Maryland coordinator as well as occasional support services, including the mailing of surveys to social workers for input on the curriculum. # A Tribute to Donald Spencer

++

he Western Maryland AHEC, earlier called the Cumberland AHEC, was operational for just two years when Don Spencer was named as Executive Director in 1979. In the ensuing two decades, under his guidance and stewardship, the Center grew in stature to emerge as a nationally recognized resource for community-based learning, serving the health professions schools of the University of Maryland as well as other universities in the region. In 1994, the Center also received a National Center award for achievement in learning resource services. Over the years, when staff at the national AHEC headquarters wanted to demonstrate a successful AHEC center to visitors, they would schedule a field trip to Cumberland to showcase a program "that does things AHECs should be doing."

WMAHEC's road to success was characterized more by peaks and valleys than by a continuous upward slope. To survive such a course, an organization requires leadership

focused steadfastly on mission and imbued with a flexible approach to adversity and uncertainty. Luckily, the Center found such attributes in its director over these two decades. He was able to attract and retain a cadre of highly effective staff who, at considerable personal sacrifice, held the program together during periods of economic turn-down. Thanks to Don's vision, encouragement, and personal participation and to the work of a dedicated staff, the Center amassed a truly impressive string of successful grant applications at the federal level. These individual initiatives were helpful in creating the "glue" that kept the program intact over exceedingly difficult periods.

Don's adherence to the principles of broad-based community input, as expressed through the structure of the Board, the Interdisciplinary Health Education Council, and the health professions caucuses, was an important factor in securing the longstanding, enthusiastic participation of volunteers representing all the professional disciplines in the region. Under Don's leadership, the Center also enjoyed strong support from friends in the Maryland State Legislature. Don was able to cultivate similarly strong and lasting friendships within the U.S. Congress. During the early 1990s when federal legislation was introduced to allow for joint federal-state funding for AHECs, the University of Maryland scheduled numerous trips to Capitol Hill. We had easy entrée to congressional offices where Don had cultivated valuable friendships among our Maryland delegation staff on both sides of the political aisle.

In recent years, a new AHEC has been launched on Maryland's Eastern Shore. Characteristically, Don gave tirelessly of his time and energies to that effort with on-site consultation during the early months of its organization. He has done all the right things in support of the principles for which he has stood and, fortunately for all of us, his imprint will be felt on the national and Maryland levels in the years to come.
